The Hall of Fame Committee will consider nominees who have made noteworthy contributions to the sport of speedskating in an amateur and non-skating capacity at the National or International level.

The candidacy of each nominee will be judged on the nominee’s record, ability, integrity, sportsmanship and character.

A nominee to the Speedskating Hall of Fame must meet two (2) of the following qualifications:

A. The nominee must have made a significant impact on the sport at the National and/or International level.

B. Has made a contribution to the sport for a period of at least fifteen (15) years.

C. Activities may include serving as an Officer, Official, Committee Member or Chairperson, Team Leader, Manager, Coach or service in promoting speedskating development.

- C. Olympic or World Championship medalists;
- D. Olympic or World Records;
- E. Olympic Teams;
- F. World Teams.

"MODERN ERA"**

Long Track: 1964 and later, Short Track: 1988 and later

A nominee to the Speedskating Hall of fame must meet the following minimum qualifications:

Achieved at least one of the following criteria five years or more prior to nomination:

A. Senior World Championships:

1. Member of at least 4 teams, achieving at least 2 top 15 finishes overall, or;
2. Earning 1 individual medal or;
3. Member of 3 relay or pursuit teams having won 2 medals.

B. Olympic Competition

1. Member of at least 3 teams, placing in the top 15 in one event, or;
2. Member of at least 1 team, earning at least 1 individual medal, or;
3. Member of at least 2 relay or pursuit teams winning 2 medals

C. World Record Performance at an ISU sanctioned competition

The candidacy of each nominee will be judged on the nominee's record, ability, integrity, sportsmanship and character.
